**Statement of Availability Capacity from other Providers:** Unless waived or otherwise provided for at the pre-application meeting, if the project is to receive sewer or potable water services from any provider other than the County, a statement from that provider indicating adequate capacity to serve the project shall be provided.

### Exhibit A Peak and Average Daily Demands

#### Group Housing (200 units)

Water:  $ADF = 200 \text{ units} \times 1.1 \text{ persons/unit} \times 150 \text{ gpd/person} \times 1.2 \text{ (peak season multiplier)} = 39,600 \text{ gpd}$

$MDF = 1.3 \times ADF = 51,480 \text{ gpd}$

Wastewater:  $ADF = 200 \text{ units} \times 1.1 \text{ persons/unit} \times 100 \text{ gpd/person} \times 1.2 \text{ (peak season multiplier)} = 26,400 \text{ gpd}$

$MDF = 1.3 \times ADF = 34,320 \text{ gpd}$

#### Residential (65 units)

Water:  $ADF = 65 \text{ units} \times 2.1 \text{ persons/unit} \times 150 \text{ gpd/person} \times 1.2 \text{ (peak season multiplier)} = 24,570 \text{ gpd}$

$MDF = 1.3 \times ADF = 31,941 \text{ gpd}$

Wastewater:  $ADF = 65 \text{ units} \times 2.1 \text{ persons/unit} \times 100 \text{ gpd/person} \times 1.2 \text{ (peak season multiplier)} = 16,380 \text{ gpd}$

$MDF = 1.3 \times ADF = 21,294 \text{ gpd}$

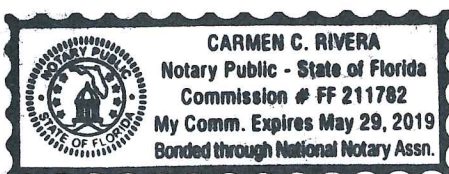
