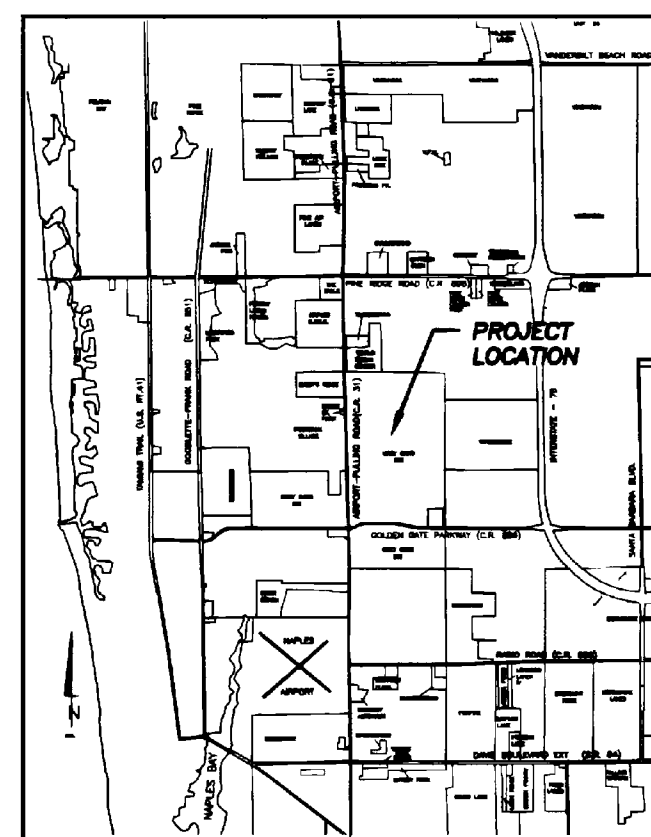
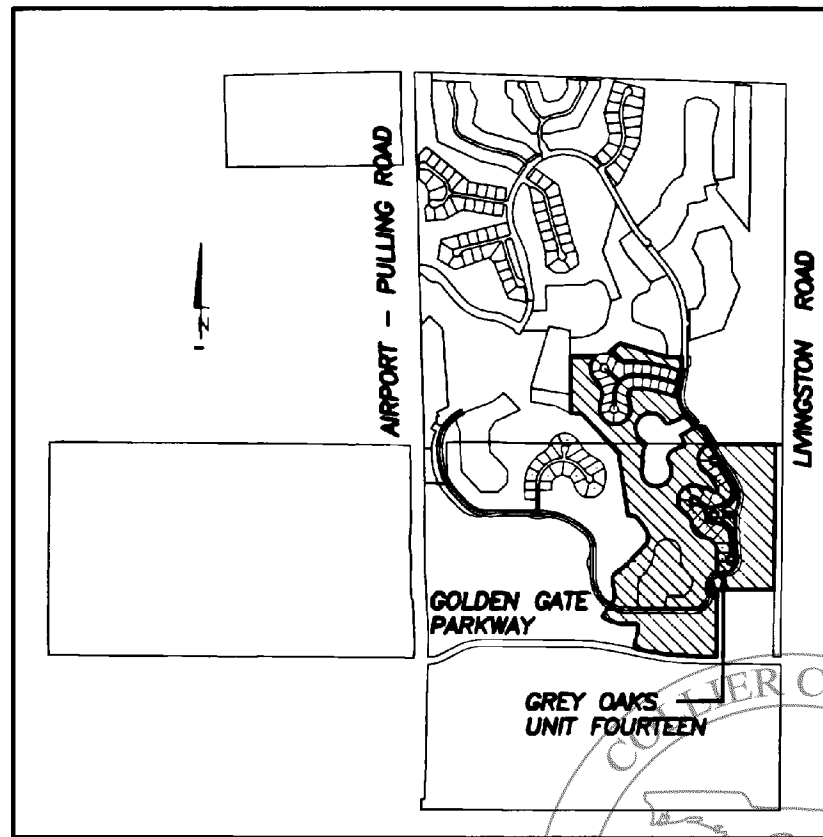

All that part of Tract "H" of Grey Oaks Unit Three according to the plat thereof as recorded in Plat Book 20, pages 30-37, Public Records of Collier County, Florida and all that part of Sections 24 and 25, Township 49 South, Range 25 East, Collier County, Florida, being more particularly described as follows:
Commencing at the southeast corner of said Section 24; thence along the east line of said Section 24, North 00°38'02" East 48.46 feet to a point on the south boundary of said Grey Oaks Unit Three; thence along the south line of said Grey Oaks Unit Three, North 89°37'55" West 120.09 feet to the Point of Beginning of the parcel herein described; thence leaving said south line South 00°31'16" West 2110.81 feet; thence North 89°41'57" West 812.00 feet; thence South 00°31'15" West 582.25 feet; thence South 00°25'08" West 353.87 feet to a point on the north right-of-way line of Golden Gate Parkway as recorded in O.R.
