Please be advised that Section 10.02.05 C.2 of the Collier County Land Development Code requires that all required subdivision improvements must receive final acceptance within 36 months from date of approval of the plat by the Board of County Commissioners. On July 14, 2014, the Board of County Commissioners approved the plat for Raffia Preserve Phase 3. Please advise this office in writing within 30 days as to your intent to complete the required improvements and receive final acceptance of the subdivision improvements. Failure to complete the improvements in a timely manner may result in the county drawing on the posted subdivision performance security to ensure compliance with the requirements of the Land Development Code.

Section 8.08.00.G.4 of the Land Development Code provides for civil penalties and remedies which include stop work orders and the suspension of building permits and / or inspections resulting from non-compliance with the requirements of the Code.

LDC Section 10.02.04 A.6 allows for 2 – two year extensions for completion of the required improvements. Any request for an extension, if applicable, must be accompanied by a fee of \$150.00.
