Hello John,

The purpose of this email is to confirm that Ave Maria would qualify for an insubstantial change permitting process for implementing signing and marking for golf cart use on roadways vs. sidewalks within the Town of Ave Maria.

We have prepared signing and marking plans and have been working with Transportation Operations. This has been approved by the BCC, and we just want to formalize the BCC's approval of golf carts using streets instead of sidewalks.

Can you confirm that we would qualify as an insubstantial change to our plat and plans (PPL) for this? I would also like to confirm the permitting fees with you - \$400 for the 1st sheet and \$100 for each additional sheet + \$100 for fire review (if applicable). Would % construction cost fees apply to this type of item? Confirmation of standards would be helpful.
